

SUSPENSION OF DRIVER'S LICENSE OR RIGHT TO APPLY TO WITH POSSIBILITY OF EARLY REINSTATEMENT

A \$25.00 FEE WILL BE CHARGED TO PROCESS YOUR REQUEST TO REINSTATE YOUR LICENSE OR RIGHT TO APPLY. A \$10.00 FEE WILL BE CHARGED TO PROCESS YOUR REQUEST FOR ADDITIONAL PRIVILEGES. PLEASE SUBMIT A CHECK OR MONEY ORDER WITH YOUR REQUEST WRITTEN OUT TO THE GEAUGA COUNTY JUVENILE COURT. (THERE WILL BE A \$30.00 CHARGE FOR ANY NSF RETURNED CHECKS.) COSTS ARE SUBJECT TO CHANGE. As a condition of your court order, your driver's license or right to apply for a license has been suspended to the age of 21 with the possibility of review for early reinstatement. In order to have your full driving privileges/ right to apply restored early, you must do the following:

1. Send the Petition for License Reinstatement form to Judge Grendell requesting the early return of your driving privileges or right to apply.
2. You must be able to verify that you are in compliance with all court orders.

If your privileges or right to apply is restored to you, a journal entry will be prepared by the court and sent to you in approximately 10 days. If your privileges or right to apply is not restored, you may request a court hearing to review the matter.

DEFINITE SUSPENSION

If your license is suspended for a definite period of time, you or a parent may pick your license up on the date the suspension ends. If the suspension ends on a weekend we will release your license to your parents on the Friday before the final suspension date. We will also release your license to a parent the day before your suspension ends however you can not drive until the morning of the suspension date.

BMV REINSTATEMENT FEE

If your license or right to apply was suspended for 90 days or more you were given information on the payment of a reinstatement fee to the BMV. This fee must be paid before the BMV will reinstate your license or right to apply for a license.

ADDITIONAL DRIVING PRIVILEGES OR CHANGE IN DRIVING PRIVILEGES

If you need additional driving privileges, you must fill out the Petition for Driving Privileges and send it to Judge Grendell. If you need to change privileges already given (i.e. new job) you must be able to verify the change to clerical staff. **There is a \$10.00 application fee to request additional privileges. (There will be a \$30.00 charge for any NSF return checks)**

DRUG SCREEN PRIOR TO RETURN OF LICENSE OR RIGHT TO APPLY

If the return of your license or right to apply is contingent upon you providing the court with a clean drug screen(s) it is your responsibility to contact the appropriate court personnel to schedule the drug screen(s). **HAIR MUST BE AT LEAST 1.5 INCHES LONG.** Anyone age 18 and over will be responsible for the cost of the drug screen. Payment is due at the time of the drug screen.

RETURN OF LICENSE OR TEMPORARY LICENSE

Unless you had a traffic offense which required your license to be sent to the BMV, your license is held by the Court. A parent may pick your license up the day before the suspension ends but must hold them until the morning of the final suspension date. You may pick your license up the day the suspension ends. If the suspension expires on a weekend a parent may pick your license up on Friday again holding them until the final suspension date. Should you wish to have your license returned to you by mail you must send a letter to the Court requesting this, include a self-addressed stamped envelope.

WHEN WRITING TO THE COURT INCLUDE YOUR NAME, CASE NUMBER, ID NUMBER, ADDRESS AND TELEPHONE NUMBER ON ALL CORRESPONDENCE.
