This matter came on for a hearing before the Magistrate Michael L. Hurst on February 21, 2024. Present in the courtroom was: Tiffany King ("Mother"); Ranee Barton ("Maternal Grandmother"); and Katie Ostrosky, Case Management.

At the hearing, the Court heard from Maternal Grandmother and Mother. Maternal Grandmother reported to the Court that T.C.K.'s (DOB: 01/31/12) behavior has been troubling as he has been acting out in school and on the bus. As for Mother she indicated to the Court that underwent a drug test through the Court. Mother also went through an IOP and is now in an individual counseling program for drugs and alcohol. Mother also indicated that she is living with her sister in Pennsylvania, and the sister has three children at that residence. Mother is seeking more permanent residency. As to employment, Mother is seeking employment.

Therefore, after hearing from Mother and Maternal Grandmother, the Court makes the following orders in the best interest of the minor child, T.C.K. (DOB: 01/31/12):

- Temporary custody of Tristyn Cameron King (DOB: 01/31/12) shall continue with Ranee Barton, pending further hearing.
- 2. Case Management shall continue to determine a supervised parenting time schedule for Tiffany King, and that the supervision of the parenting time is by a person or agency determined by the Case Management.

- 3. Tiffany King shall continue to fully comply with all recommendations from her individual counseling drugs and alcohol program.
- 4. Ranee Barton and Tiffany King shall sign all release of information forms on behalf of Case Management and CASA.
- 5. A CASA shall be appointed for **T.C.K.** (**DOB: 01/31/12**) by separate entry.
- As for service on Joseph King and Matthew Dipiano, it is incumbent upon Ranee
 Barton to file with the Court an update Request for Service on Joseph and Matthew's addresses, respectively.
- 7. This matter is set for a pretrial on April 3, 2024 at 10:00 am.
